
## What is Shyft?

It's a payment app that converts rands into four currencies – US dollars, Austrialian dollars, euros and pound sterling.

Here's what to do:

- 1. Download Shyft from your app store.
- 2. Create an account by following the prompts.
- 3. Transfer your rands from your South African bank account onto the Shyft app. You can then exchange your rands into the currency that you need.
- 4. Use the foreign currency to make payments online or abroad, pay for things when you travel,

trade currencies, and of course, invest offshore.

Shyft saves time, paperwork, effort and is cost-effective. And it's free to use with no monthly fees. Also, Shyft offers some of the best and cheapest foreign exchange rates in the market, with low transaction fees.

Three steps to offshore investing

- 1. You're ready to invest offshore and the funds are available in your South African bank account, but you need to convert them to a foreign currency such as US dollars.
- 2. You have been screened for FICA by your authorised intermediary and approved for investment.
- 3. You make the physical payment into the investment e.g., Offshore Investment Plan, using Shyft.
