I would like to take this opportunity to thank you, and to let you know that your partnership with us is deeply valued.

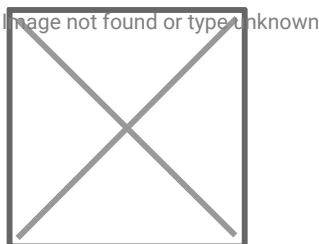
